This Corporation is authorized to issue 7,500 shares of \$1.00 par value common stock.

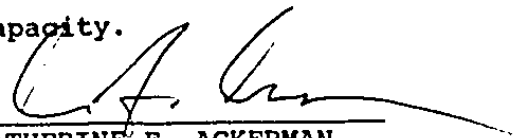
Article V - Initial Registered Office
