ARTICLE I - Name

The name of the corporation is **HECK AGENCY CORP.**

ARTICLE II - Duration

This corporation shall exist perpetually.

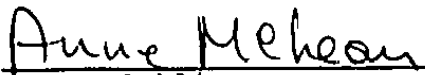
