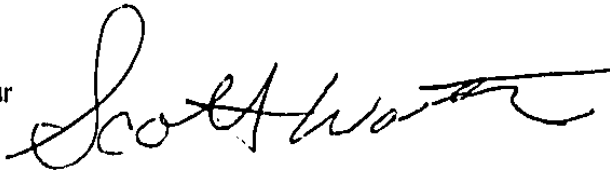

#### ARTICLE XIII

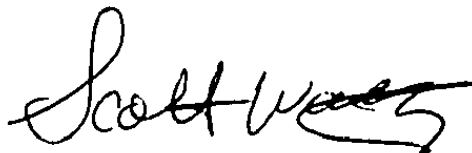

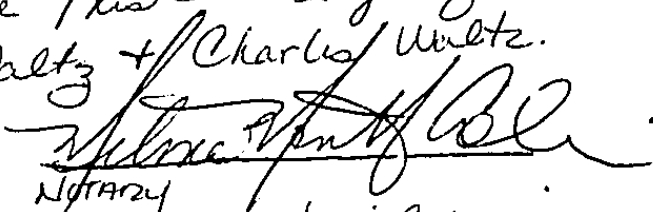

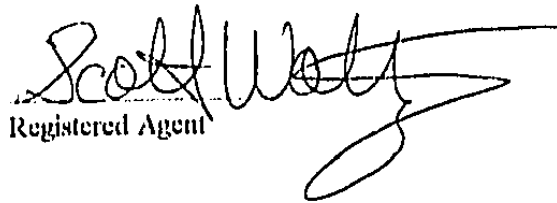
