**ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby certifies and adopts the following Articles of Incorporation:

**ARTICLE I.**

**NAME**

The name of this Corporation shall be "DORSCH MANAGEMENT, INC."

**ARTICLE II.**

**PRINCIPAL OFFICE**

The principal place of business and mailing address of this Corporation shall be 6326 Maclaurin Drive, Tampa, Florida 33647.

**ARTICLE III.**

**SHARES**
