The undersigned, in order to form a corporation for the purpose harminafter stated, under and pursuant to the General Corporation Act of the State of Florida, do hereby certify as follows.

ARTICLE !

NAMB

The name of this corporation is: IFU CORPORATION

ARTICLE U

CURPOSE

The general nature of the business to be transacted by this corporation shall be:

- A) Import, Export and Trading
- personal property, chattels, rights, essements, permits, privileges and franchises as may lawfully be purchased, exchanged, hired, or acquired.

- c) To erect, construct, maintain, improve, rebuild, enlarge, alter, manage, and control directly or through ownership of stock in any corporation, any and all kinds of buildings, houses, hotels, bungalows, stores, offices, warehouses, mill, shops, factorics, machinery and plants, and any and all structures and erections which may at any time necessary, useful, or advantageous in the judgment of the Board of Directors, for the purpose of the corporation, and which can lawfully be done.
- b) To sell, manage, improve, develop, assign, transfer, convey, lease, sublease, pledge or otherwise encumber the lands,


