## FILED ARTICLES OF INCORPORATION 95 MAY 15 PM 3: 40

TKH, INC.

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### **ARTICLE 1**

#### Corporate Name and Principal Office

The name of this corporation is TKH, Inc., a Florida corporation and its principal office and mailing address is 3102 East 138th Avenue, Tampa, FL 33613.

#### **ARTICLE II**

Commencement of Corporate Existence

The corporation shall come into existence on May 12, 1995.

#### ARTICLE III

#### General Nature of Business

The corporation may transact any lawful business for which corporations may be incorporated under Florida law.

#### ARTICLE IV

#### Capital Stock

The aggregate number of shares of stock authorized to be issued by this corporation shall be 7,500 shares of common stock, each with a par value of \$1.00.
