# ARTICLES OF INCORPORATION OF SERVICE FRANCO-VIDEO, INC.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

#### ARTICLE 1 - Name

The name of the corporation is SERVICE FRANCO-VIDEO, INC.

## ARTICLE II - Commencement of Existence and Duration

This corporation is to commence its corporate existence on the date of the filing of these Articles of Incorporation pursuant to Fla. Stat. §607.167] and shail exist perpetually thereafter until dissolved sooner according to law.

#### ARTICLE III - Purpose

The corporation is organized for the purpose of transacting any and all lawful business.

#### ARTICLE IV - Stated Capital

The corporation is authorized to issue 5,000 shares of ONE DOLLAR (\$1.00) par value common stock. Each outstanding share, regardless of class, shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.
