**ARTICLES OF INCORPORATION**

**OF**

**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is **JOHN DONAHER PAINTING & DECORATING, INC.**, and its principal place of business shall be located at 701 Robin Ave., Palm Harbor, Florida 34683.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.
