OF

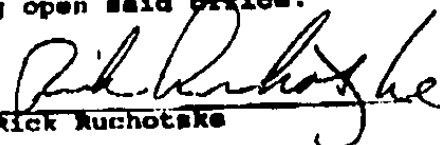
