ARTICLES OF INCORPORATION OF LITTLE, EVANS & ZIMMERMAN, P.A.

The undersigned person, competent and licensed to practice law in the State of Florida, acting hereby as Incorporator for the uprpose of forming a Professional Service Corporation for profit under the provisions of Chapter 607, Florida Business Corporation Act, and Chapter 621, Florida Professional Service Corporation and Limited Liability Company Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE 1: NAME:

The name of this Corporation is:

LITTLE, EVANS & ZIMMERMAN, P.A.

ARTICLE 2: DURATION:

The term of existence of the Corporation is perpetual.

ARTICLE 3: PURPOSE:

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- a. To engage in every aspect in the practice of law, and all its fields of specializations, as are engaged in by members in good standing of the Florida Bar.
- b. To engage and render the professional services involved only through its officers, agents and employees who shall be attorneys in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation.

- c. To engage in no other business other than the rendition of the professional services specified herein.
- d. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

- a. The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be one thousand (1,000) shares of common stock at One Dollar (\$1.00) per share par value.

- c. Shares of the corporation's stock and certificates shall be issued only to real estate professionals in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.
