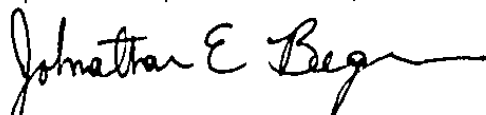

ARTICLES OF INCORPORATION
of

ARTICLE I - NAME

This corporation shall exist perpetually.

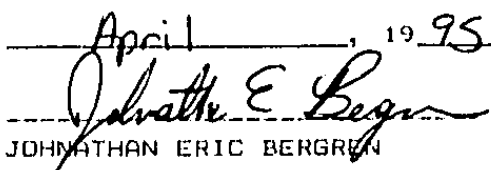
