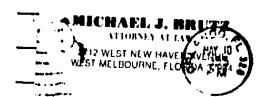

ARTICLE I Name SECHLIAR (UP STATE TALLAHASSEE, FLORIDA

The name of this Corporation is Alice Petty, Inc.

ARTICLE II Duration

The Corporation shall have a perpetual existence.
