**ARTICLES OF INCORPORATION

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

**ARTICLE I - Name**

The name of the corporation is **FRANK TURNER CONSTRUCTION CORP.** The principal place of business of the corporation is 10 East Greens Circle, Lehigh Acres, Florida 33936. The mailing address of the corporation is 10 East Greens Circle, Lehigh Acres, Florida 33936.

**ARTICLE II - Commencement and Duration**

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

**ARTICLE III - Purpose**

The corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV - Stated Capital - Classes of Stock**

The corporation is authorized to issue 1000 shares of common stock at \$1.00 par value.
