

## ARTICLES OF INCORPORATION (1.1.) OF H & R CUPBOARDS, INC.

#### ARTICLE I CORPORATE NAME

The name of this corporation shall be: H & R CUPBOARDS, INC. The address of the principal office of this corporation shall be 5337 Cocoa Ct., Cape Coral, Fl, 33904, and the mailing address shall be the same.

## ARTICLE II NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

## ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock (having a par value of \$1.00 per share).

amendment of these Articles of Incorporation be made.


