ARTICLES OF INCORPORATION
of
DL CONSTRUCTION OF SOUTHWEST FLORIDA, INC.

1. **NAME.** The name of the corporation shall be DL CONSTRUCTION OF SOUTHWEST FLORIDA, INC.

2. **PURPOSES.** The general nature of the business to be carried on by the corporation shall be:

A. To make, perform or carry out contracts of any and every kind with any person, firm, corporation, association or other entity; and to do all or any acts in the conduct of its business not prohibited by the laws of the State of Florida.
