# ARTICLES OF INCORPORATION

OF

# TEAM ONE COMMUNICATIONS, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

### ARTICLE I: NAME

The name of the corporation is: **TEAM ONE COMMUNICATIONS, INC.**The principal mailing address of the corporation is 2112 W. Yonge Street, Pensacola, Florida 32505.

# ARTICLE II: NATURE OF BUSINESS

This corporation is organized for the purpose of transacting all lawful business for which corporations may be incorporated under the Florida General Corporation Act, effective January 1, 1976.
