ARTICLE I - NAME

The name of this corporation is OPTICIANS REFERRAL NETWORK, INC. (the "Corporation").

ARTICLE II - PURPOSE

This Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
