ARTICLE I - NAME

The name of this corporation is Random Sales and Service, Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually. The date of commencement of the corporation shall be May 20, 1995.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of engaging in any business activity permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 5,000 shares of \$1.00 par value common stock.

ARTICLE X - COMPENSATION OF DIRECTORS

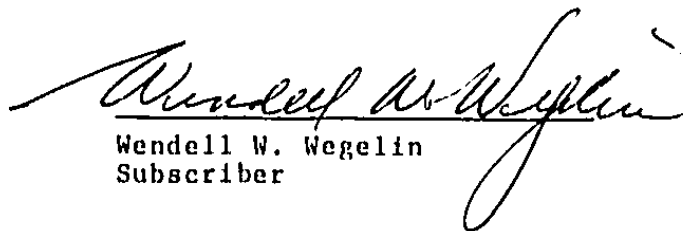
The shareholders of this corporation shall have the exclusive authority to fix the compensation of directors of this corporation.

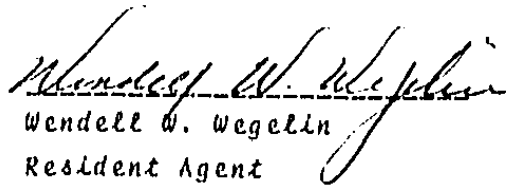
