ARTICLES OF INCORPORATION OF LEGUNES, INC.

The undersigned, for purposes of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

# ARTICLE I

The name of the corporation shall be LEGUMES, INC.

# ARTICLE II DURATION

The term of existence of the corporation is perpetual.

# ARTICLE III PURPOSE

The purposes of the corporation are:

- (a) To engage in the ownership and operation of restaurants, and to engage in training, consulting and educational activities relating to retaurants, food service and food preperation.
- (b) To engage in and to transact any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida.

### ARTICLE IV CAPITAL TOCK

The aggregate number of shares which the corporation has authority to issue is one thousand (1000) shares, all of which shall be common shares with a par value of one dollar (\$1.00).

# ARTICLE V REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered cffice of the
