ARTICLE I. CORPORATE NAME

The name of this Corpt cion is: TAMPA CEINA MOON CAPE, INC.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to introduce, erect, operate, conduct, manage, maintain, and carry on a restaurant and bar; to buy, sell, lease, or otherwise dispose of, and to operate, conduct, furnish, equip, and manage restaurants, cases, and bars and generally do and perform everything necessary for carrying out the aforesaid purposes; to buy, or otherwise acquire, manufacture, market, prepare for market, sell, deal in, and deal with, import and export food products of every class and description, fresh, canned, preserved or otherwise; and to prepare and serve all food, beverages, alcoholic or nonalcoholic, and other preparations and refreshments of all kinds and to engage in any and all business permitted under the laws of the State of Florida.
