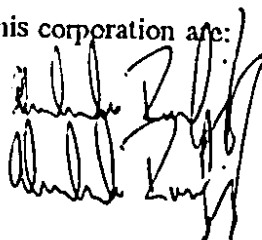

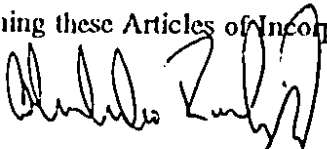

Amendment of Articles

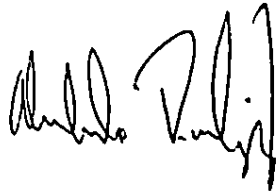

Preemptive Rights

Each shareholder of this corporation shall have the first right to purchase (and securities convertible into shares) of any class, kind, or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares held at the time of issue bears to the total number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares preemptive within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him/her to exercise

his/her pre-emptive rights. This right might also be waived by an affirmative written waiver submitted by the shareholder, to the corporation within thirty (30) days of receipt of notice from the corporation.
