The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby from a corporation under the laws of the State of Florida.

**ARTICLE I - CORPORATE NAME**

The name of the corporation is 2000 CLUB, INC.

**ARTICLE II - DURATION**

The corporation shall exist perpetually unless dissolved according to Florida law.

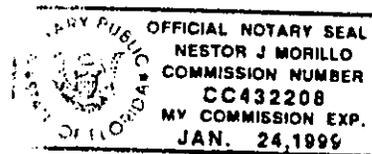
