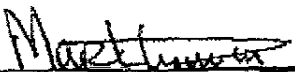
1. ARTICLE ONE of the Articles of Incorporation of GULF BREEZE LAND, INC. is amended to read as follows:

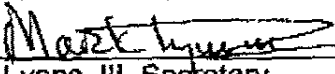
ARTICLE ONE

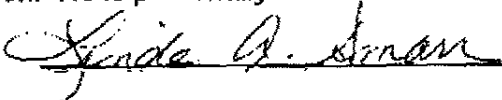

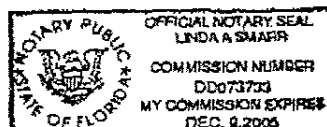
