ARTICLES OF INCORPORATION

OF

CALHOUN ELECTRIC SERVICE, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is CALHOUN ELECTRIC SERVICE, INC.

The principal office and mailing address of this corporation is

The duration of the corporation is perpetual.
