The undersigned, for the purpose of forming a corporation under the General Corporation Act hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be B.G. Construction, Inc.

ARTICLE II

DURATION

This corporation shall exist perpetually.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV

CAPITAL STOCK

This corporation is authorized to issue five (5) shares of common stock, which shall be designated "Common Shares".

ARTICLE V

PREEMPTIVE RIGHTS
