ARTICLE I NAME

The name of the corporation shall be: Power Rooter, Incorporated.

ARTICLE II PRINCIPLE OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III SHARES

The total number of shares the corporation is authorized to issue is 250 divided into 200 shares of Class A common stock and 50 shares of Class B common stock. The following is a description of each class of stock of the corporation with the preferences, conversion, and other rights, restrictions, voting powers, and qualifications of each class:

1. Except as hereinafter provided with respect to voting powers, the Class A common stock and the Class B common stock of the corporation shall be identical in all respects.

2. With respect to voting powers, except as otherwise required by the laws of the State of Florida, the holders of Class A common stock shall possess all voting powers for all purposes including, by way of illustration and not limitation, the election of directors, and holders of Class B common stock shall have not voting power whatsoever, and no holder of Class B common stock shall vote on or other wise participate in any proceedings in which actions shall be taken by the corporation or the stockholders thereof or be entitled to notification as to any meeting of the Board of Directors or the stockholders.

At onset of this incorporation, it is known that the incorporators equally own all of the Class A stock (50 shares each).

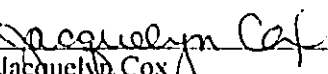
To provide complete sewer and drain service. Although the corporation is not a primary plumbing contractor, this may be a service provided in the future.
