AFTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is: EAGLE GOLF CARDS, INC. The principal address of the corporation is 700 SE SIXTH AVENUE, POMPANO BEACH, FL 33060.

This corporation shall have perpetual existence commencing on the date of the filing of this Articles with the Department of State.
