WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

- FIRST: The name of the corporation is All-State Home Improvement, Inc.
- SECOND: The period of its duration is Perpetual.
- THIRD: The purpose(s) for which the corporation is organized are To operate a Contracting Company, and any other lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes.
- FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 7500, par value of 1 Dollar (1.00) each.



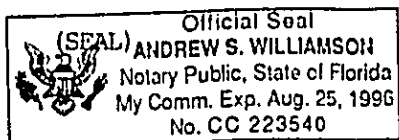
