ARTICLES OF INCORPORATION

SECRETARY OF STATE THE LOUELLA HARRIS GROUP FOR THE ADVANCEMENT OF SEE, FLORIDA ATLAS ORTHOGANAL CHIROPRACTIC, INC.

I, the undersigned, make, subscribe, acknowledge and file with the Secretary of State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE ONE -NAME

The name of the corporation shall be:

THE LOUELLA HARRIS GROUP FOR THE ADVANCEMENT OF ATLAS ORTHOGANAL CHIROPRACTIC, INC.

ARTICLE TWO - PURPOSE

The general purpose or purposes for which the corporation is initially organized shall include the transaction of any and all lawful business for which a corporation may be incorporated under Chapter 607, Florida Statues (1991).

ARTICLE THREE

EXISTENCE OF CORPORATION

The corporation shall begin existence on the filing of these articles and shall have perpetual existence.

ARTICLE FOUR

CAPITAL AND NON-CAPITAL STOCK

- (A) The total number of shares of capital stock authorized to be used by the corporation shall be one thousand (1,000) shares having a par value of One (\$1.00) Dollar per share. Each of said shares of stock shall entitle the holder thereof to one vote at any meeting of the stockholders. All or any part of said capital stock may be paid for in cash, in property or in labor or services at a fair evaluation to be fixed by the Board of Directors at a meeting called for such purpose. All stock when issued shall be paid for and shall be nonassessable.
- (B) In the election of directors of this corporation, there shall be no cumulative voting of the stock entitled to vote at such election.
- (C) The total number of shares of non-capital stock authorized to be used by the corporation shall be seven thousand (7,000) shares, Pursuant to Section 607.054(2), Florida Statutes (1991), all non-capital shares of stock shall be non-voting shares of no par value. It is the intention of the undersigned incorporator that certain of these non-capital, non-voting shares of stock shall be issued from time to time to persons assisting THE LOUELLA HARRIS GROUP FOR THE ADVANCEMENT OF ATLAS ORTHOGANAL CHIROPRACTIC, INC. No person issued non-capital, non-voting shares of stock shall be entitled to receive any stock dividend.
