# ARTICLES OF INCORPORATION OF SLEEP MASTERS, INC.



The undersigned hereby executes the following for the purpose of forming a corporation under the laws of the state of Florida providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit.

## ARTICLE 1 - NAME

The name of the corporation shall be SLEEP MASTERS, INC.

#### ARTICLE 2 - PROPOSE
