

Article I - Name

The name of this corporation is OAKOWSKY MANAGEMENT AND COMPUTER SYSTEMS, INC.

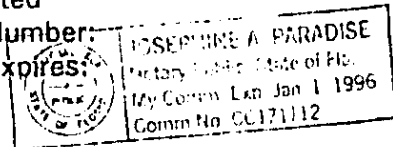
