The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name

The name of the Corporation is: **FOOD COURT EXPRESS, INC.** The principal address of the corporation is 1060 Pinellas Bayway, #103, Tierra Verde, FL 33715. The mailing address is Post Office Box 66738, St. Petersburg Beach, Florida 33736.

Article 2. Purpose

The Corporation shall have the power to engage in any lawful activity for which corporations may be organized under the Florida Business Corporation Act.

Article 3. Authorized Shares

The aggregate number of shares which the Corporation is authorized to issue is 10,000 shares of common stock. Such shares shall be of a single class.

Article 4. Initial Registered Office and Agent

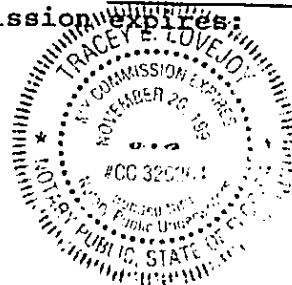
