STATE OF FLORIDA ARTICLES OF INCORPORATION

E T MAINTENANCE SERVICES, INC.

The undersigned, acting as Incorporator of a corporation pursuant to the Florida General Corporation Act, adopts the following Articles of Incorporation.

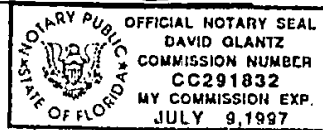
