WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

- FIRST: The name of the corporation is MINSHALL ENTERPRISES, INC.
- SECOND: The period of its duration is PERPETUAL
- THIRD: The purpose(s) for which the corporation is organized are TO OPERATE AN AUTO SALAGE / AND ANY OTHER LAWFUL BUSINESS ACTIVITY FOR WHICH CORPORATIONS MAY BE INCORPORATED UNDER CHAPTER 607 OF THE FLORIDA STATUTES.
- FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 500 SHARES OF COMMON STOCK HAVING \$1.00 PAR VALUE PER SHARE.

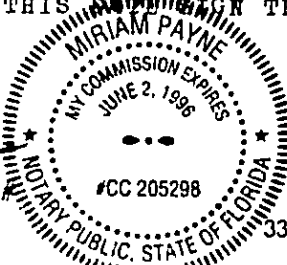
