ARTICLE I

NAME OF CORPORATION

The name of this corporation shall be:

ARTICLE II

PRINCIPAL OFFICE

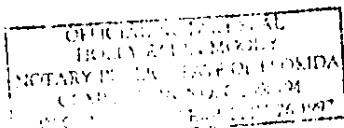
