NAME

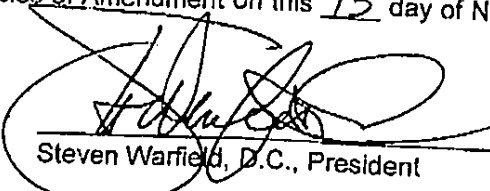
