ARTICLES OF INCORPORATION (Professional Corporation)

of

The undersigned, who is duly licensed to practice dentistry in the State of Florida, desiring to form a professional corporation in accordance with Chapters 607 and 621 of the Florida Statutes and the Florida Professional Services Corporation Act, adopts the following Articles of Incorporation:
