ARTICLES OF INCORPORATION
of
Dove Data Services, Inc.

The undersigned incorporator, for the purpose of forming a for-profit corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I: Name

The name of the corporation is: Dove Data Services, Inc.

ARTICLE II: Purpose

The purpose for which the corporation is organized is the transaction of any lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE III: Period

The period of its duration is perpetual.

ARTICLE IV: Principal Office

ARTICLE V: Shares

The corporation is authorized to issue one class of stock, that stock being 1000 shares of no par value, common stock, with identical rights and privileges, the transfer of which is restricted according to the bylaws of the corporation.


