ARTICLE 1: NAME AND ADDRESS

The name of this Corporation is : B.I.R.D., INC. and the address is: 2635 US 19, Holiday, FL 34691.

ARTICLE 2: DURATION

This Corporation shall exist perpetually. In accordance with Section 607.0203, the corporation effective date requested is five (5) business days prior to the date of filing.

ARTICLE 3: PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE 4: CAPITAL STOCK

This Corporation is authorized to issue 1000 shares of \$1.00 par value common stock.

ARTICLE 5: COMMENCEMENT OF BUSINESS

The Corporation will not commence business until it has received for the issuance of shares consideration of the value of \$1000.00 consisting of money, labor done or property actually received.
