

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME OF CORPORATION

The name of the corporation is F&M, INC.

ARTICLE TWO

PRINCIPAL OFFICE

The principal office of the corporation will be 10306 WELLEY ISLES BLVD. SUNRISE, FLORIDA 33351.

ARTICLE THREE

PURPOSE
