OF

ARTICLE I. NAME AND ADDRESS

The name of this corporation shall be: STORM CONSTRUCTION INC. The principal place of business of this corporation shall be: 715 Harriet Ave. SW, Palm Bay, Florida, 32908.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK
