The name and address of the initial registered agent is Neal Sandberg, Esq., 2650 Biscayne Blvd., Miami, FL 33137-4590.

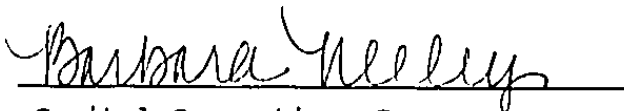

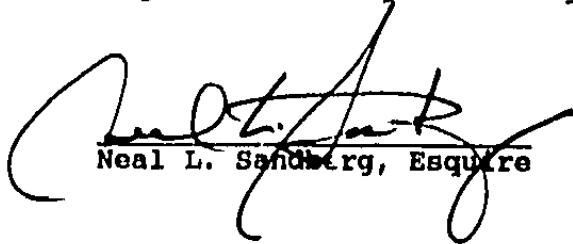
