The undersigned subscriber to these Articles of Incorporation, being a natural person, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is JENSEN ROOFING, INC.

The holders of shares of stock shall have preemptive rights to purchase any shares of the Corporation hereafter issued in proportion to their holdings for the stock to be issued.

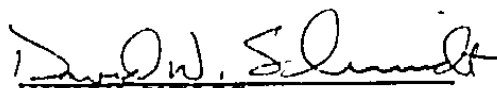

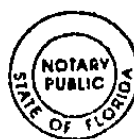
