ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is LA HERMANDAD DEL VINO, CORP. (THE WINE BROTHERHOOD) Translation

ARTICLE II - DURATION

This corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida.
