ARTICLES OF INCORPORATION

AMALIADA, INC.

The undersigned for the purpose of forming a corporation under the Florida General Corporation Act do hereby adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the corporation is AMALIADA, INC.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purposes for which the corporation is organized are:

- 1. To engage in the business of and to construct, buy, sell, lease, equip and operate restaurants, cafes and hotels; to manufacture, grow, compound and create and generally deal in all kinds of food, food stuffs and food products.
- 2. To transact any other lawful business for which corporations may be incorporated under the General Corporation Act of Florida or engage in any trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
- 3. To do such other things which the corporation is authorized and which are incidental to the foregoing or necessary and desirable in order to accomplish the foregoing.

ARTICLE FOUR

The aggregate number of shares which the corporation is authorized to issue is ONE THOUSAND FIVE HUNDRED. Such shares shall be of a single class and shall a par value of One (\$1.00) Dollar per share.

ARTICLE FIVE

Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders and approved at a stockholder's meeting by a majority of the stock entitled to vote thereon unless all directors and all stockholders sign a written statement manifesting their inention that a certain amendment of the articles of incorporation be made.
