ARTICLES OF INCORPORATION

of

D'S PLACE INC.

ARTICLE I - NAME

The name of the corporation is ----- D'S PLACE INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE
