The undersigned hereby subscribes to these Articles of Incorporation to form a corporation under the laws of the State of Florida.

I.

The name of the corporation is TATUM BAIT, TACKLE AND GROCERY, INC.

II.

This corporation is organized for the purpose of selling Bait, tackle and groceries in Pinellas and other counties, and for the purpose of the transaction of any or all lawful business for which corporations may be incorporated under Florida Statutes, Chapter 607.

III.

This corporation is authorized to issue 1,500 shares of \$5.00 par value common stock. The subscription of said stock shall be paid for in lawful money of the United States of America, or in other property, exclusive of stock or securities. In the event that any such property exchanged for stock has no easily certifiable value, such valuation shall be fixed by the Board of Directors at the regular or special meeting called for that purpose. The corporation may from time to time increase its capital stock to any amount that may be from time to time authorized by law.

IV.

Every shareholder, upon the sale for cash or any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

V.

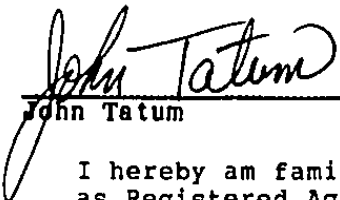

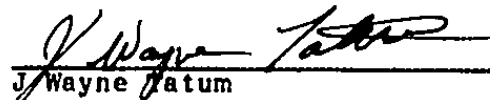

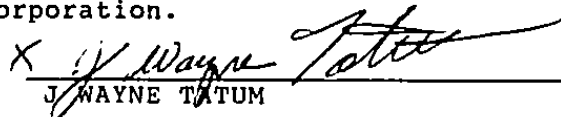
