#### ARTICLES OF INCORPORATION

OF

BROOKE'S MOBILE TIRE SERVICE, INC.

EFFECTIVE VATE

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Corporation under the laws of the State of Florida.

### ARTICLE I. NAME

The name of this Corporation shall be BROOKE'S MOBILE TIRE SERVICE, INC.

# ARTICLE II. ADDRESS

The principal place of business of this Corporation shall be 35 S.W. 13TH TERRACE, CAPE CORAL, FLORIDA 33991. The Board of Directors may from time to time move the principal business office to any other address within proutbide the State of Florida, and may establish branch offices in such other place or places as may be designated by the Board of Directors.

#### ARTICLE III. NATURE OF BUSINESS
