# ARTICLES OF INCORPORATION OF KLAUS STRUBEL'S FINE ART ATELIER, INC.

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

#### ARTICLE I - Name

The name of the corporation is **KLAUS STRUBEL'S FINE ART ATELIER, INC.** The principal place of business of the corporation is c/o 3031 Skipper Lane, St. James City, Florida 33956. The mailing address of the corporation is c/o 3031 Skipper Lane, St. James City, Florida 33956.

#### **ARTICLE II - Commencement and Duration**
