# ARTICLES OF INCORPORATION OF SETTLES/DAVIS REAL ESTATE, INC.

The undersigned subscriber to these Articles of Incorporation does hereby form a corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes.

### ARTICLE I NAME OF CORPORATION

The name of this Corporation shall be SETTLES/DAVIS REAL ESTATE, INC.

## ARTICLE II GENERAL MATURE

The general nature of the activities of this Corporation shall be a real estate brokerage business and the transaction of any or all lawful business for which corporations may be incorporated under this Chapter 607 Florida Statutes.

### ARTICLE III CAPITAL STOCK

- A. The maximum number of shares of capital stock that this Corporation is authorized to is ... and have outstanding at any one time is One Hundred Thousand Shares (100,000) of Common Stock having a par value of One Dollar (1.00) per share, which shall be with preemptive rights.




